## **MDC GUIDELINES FOR EVANGELISM GRANTS**

1. Grants are made available to congregations, or to presbyteries for presbytery-wide evangelism, throughout the year.
2. Grant applications must be approved by the session, presbytery and the Ministry Development Committee before the event. The Committee has no obligation to consider retrospective grant applications.
3. Applications must include a clear description of the evangelistic activity or event to be supported, and itemised costings of the various elements of the activity or event.
4. "Evangelism events" need not be a single event but may be a series of events over several weeks or months.
5. Evangelism events must be serious endeavours at evangelism and more than letterbox drops and the like. The target community must be the unsaved and backslidden. Events of a primarily teaching or training nature do not qualify.
6. All supported Evangelistic events must include a "follow up" strategy. A précis of this strategy must be included in the grant application.
7. A post-event report regarding the evangelistic activity or event must be supplied to the Ministry Development Committee through the presbytery.
8. Evangelism Grants are currently "capped" at a maximum total of \$1500 per charge per year.
